Purpose and Objectives of PLC

- PLC is a condition under the Environmental Compliance Approval (ECA)
- Function in accordance with the Terms of Reference for the PLC, as amended

"The PLC shall serve as a forum for dissemination, consultation, review and exchange of information regarding the operation of the landfill Site, including environmental monitoring, maintenance, complaint resolution, and new approvals or amendments to existing approvals related to the operation of this landfill Site."

- PLC members and their roles
- PLC Meetings are open to the public and shall be held in public
- The PLC may hear deputations from any member of the public or interested agency pertaining to the Site and its operation

Site Update

Leachate Treatment Plant

- Power has been restored to the treatment plant and testing of the computer controls systems has started. The main controller was damaged, and a replacement has been ordered. Further assessment will follow the main controller installation.
- Raw leachate has been hauled to a wastewater treatment plant.
- Discharge to the roadside ditch will not resume until the treatment plant is repaired and permission from the MECP to resume discharge has been obtained.

Haldimand Treatment Plant

 The annual agreement allowing 154 m3/day of treated effluent has been renewed.

Community

 After hearing back from the Cayuga foodbank regarding positive effect of the previous donation, Brooks Road provide the Cayuga Foodbank with a second donation of \$10,000 in late October.





Hauling and Leachate Level Update

 From June to October, 1,971,890 L of leachate was hauled to an off-site wastewater treatment plant. At of the end of October the leachate level was measured at 196.3 m.

Increased efforts to reduce leachate level

- Maintain hauling of raw leachate, targeting 126m3/day to a licensed treatment facility;
- New agreement with Haldimand County wastewater treatment plant allowing for treated effluent TSS concentration to increase from 10 mg/L to 30 mg/l. The agreement keeps the 156m3/day hauling in place.

Preparation for Final Cover installation

 West side slope has been graded and is near final elevations. Work is progressing to cap internal contact water ditch with clay and to grade perimeter ditch to received clean runoff and convey it to the stormwater pond.

Landfill Life Expectancy

- Capacity Survey conducted August 8, 2024
- The site is close to the permitted capacity and receiving of waste has been paused until the remaining capacity can be assessed from the November 12, 2024 survey











Site Approvals – EA

- BRE has completed the Environmental Screening process to add additional capacity by 219,400 m³. The approved footprint is expected to change as a result of the increased capacity.
- The final Environmental Screening Report was posted for a 60-day review period from April 2024 to June 24, 2024. Statement of Completion issued in August 2024.
- An ECA Application for the additional capacity was subsequently submitted to the MECP in June 2024.
- An ECA Amendment Application to approve a portion of the capacity increase (32,000 of the 219,400) was also submitted to the MECP in September.
